Welcome and Call to Order

Evelyn Seel, MPH, Acting Executive Director, NPRSB and NACCD Designated Federal Official CDR, U.S. Public Health Service U.S. Department of Health and Human Services

CDR Evelyn Seel called the meeting to order, and welcomed the National Preparedness and Response Science Board (NPRSB) and National Advisory Committee on Children and Disasters (NACCD) members, ex-officio members, and the public in attendance. She provided a brief overview of the Federal Advisory Committee Act (FACA) and Conflict of Interest rules. She stated that the purpose of this joint NACCD and NPRSB public meeting was for members to receive informational updates on pertinent activities, programs and priorities within the Office of the Assistant Secretary for Preparedness and Response (ASPR), the National Health Security Strategy (NHSS) and from other relevant stakeholders. CDR Seel took the roll call for NPRSB and NACCD voting members and ex-officio members present. Then she introduced Dr. Steven Krug, Chair of the NPRSB, for his welcoming remarks.

Chair Welcoming Remarks

Dr. Krug welcomed and thanked everyone for attending this meeting. He expressed gratitude for the speakers and presenters on the day's agenda for taking the time out of their busy day and week to inform the members of their programs and priorities. He introduced the first presenter, Darla Eisemann to provide an overview of the HHS Budget Cycle.

The Office of Financial Planning & Analysis (OFPA) leads ASPR efforts to align financial resources to its strategic priorities. It conducts annual planning under a multi-year strategy, measures performance and alters course when necessary. OFPA formulates monitors and evaluates budgets and financial plans to support program activities and ensures the efficient execution of ASPR's financial resources.

Steps in the ASPR funding process:

- 1. The Assistant Secretary's request to the Secretary
- 2. The Department's request to the White House Office of Management and Budget
- 3. The President's Budget to Congress
- 4. The Congressional Budget Resolution & Appropriations

The mission of the EMSC program is to reduce child and youth mortality and morbidity resulting from severe illness or trauma with three goals:

- To ensure that state of the art emergency medical care is available to ill or injured children and infants when needed.
- To ensure that pediatric services are well integrated into the existing state emergency medical services system and backed by optimal resources.
- To ensure that the entire spectrum of emergency services -- including primary prevention of illness and injury, acute care, rehabilitation -- is provided to children and infants at the same level as adults.

Dr. Phillips briefly highlighted that the Office of the Assistant Secretary for Preparedness and Response was created under the 2007 Pandemic and All Hazards Preparedness Act (PAHPA) in the aftermath of Hurricane Katrina. ASPR is to lead the nation in preventing, preparing for, and responding to the adverse health effects of public health emergencies and disasters. She described ASPR's priorities and the charge from the new HHS Secretary Thomas Price to focus on patients, people, and partnerships.

ASPR Priorities

- Lead the nation in preparing for, responding to, and recovering from Public Health and Medical Emergencies ranging from natural disasters to infectious disease outbreaks
- Make advances in medical countermeasures development and procurement

Advancements based on previous Federal Advisory Committee Recommendations

- Hurricane Sandy Grant Program Update
- Disaster Science Program Development

ASTHO's primary function is to track, evaluate and advise members on the impact and formation of public or private health policy which may affect them and to provide guidance and technical assistance on improving the nation's health.

Five Priorities of ASTHO are:

- 1. Supporting wellbeing, disease prevention, and health promotion as key strategies to improve health and reduce healthcare costs
- 2. Ensuring domestic health security and rapid response to public health emergencies
- 3. Strengthening the public health infrastructure at the state and territorial level to deliver essential public health services

- 4. Implementing public health programs to meet the specific needs and address the priorities of the state and local health agencies
- 5. Improving the health outcomes and delivery and return on investments across the public health enterprise

This year Dr. Butler, the President, identified challenges in preventing substance abuse and addictions. ASTHO is challenging the members to use evidence-based strategies and tactics to make a difference in the opioid epidemic and in other types of substance abuse concerns. ASTHO has seven policy committees that state health officials and others belong to representing priority areas.

Public Comment

The NACCD and NPRSB received a public comment from the President of the American Association of Blood Banks (AABB). AABB is a leader in standards development, accreditation and implementation of quality systems in transfusion medicine and cellular therapies.

Ann Stone, Director of Public Policy Advocacy for the AABB, was in attendance at the meeting and expressed the association's concern with blood sustainability in the transfusion community. She stated the lack of data on blood utilization in the emergency preparedness mission space. She encouraged the NACCD and NPRSB to explore this issue in the future. The chairs of both the advisory committees thanked her for the AABB's letter and for bringing this issue to their attention.
